

Welsh Government Policy: Future Wales 2040


- Welsh Government Targets
 - 70% of electricity generated by renewables by 2030
 - Climate emergency and International commitments
- Makes the assumption that the only thing a third of Carmarthenshire is good for are windfarms and solar arrays
- The unspoilt places that we think of as special will be ruined
- Farms face conversion to windfarms or forestry
- Our way of life, culture and language is under threat



Welcome to industrial 'renewables'



- Carmarthenshire's New Local Plan contains a target for 588.5 MW of additional installed wind turbine capacity by 2033
- In reality this means up to 90 new turbines, or development across almost 14,542 acres of the pre-assessed area higher ground on NRW land and in our forestry areas
- Communities in north Carmarthenshire face being surrounded by multiple pylon chains, windfarms, solar farms, battery storage plants and there is the prospect of pumped hydro
- The initial energy parks and chains of pylons are just the start






- Developed by Galileo Empower Ltd via wholly owned "Galileo 06"
- 19 wind turbines, battery storage, solar PV, associated infrastructure and access routes
- Currently in pre-planning consultation
- Public consultation deadline 1st October 2025, aim to submit formal submission end 2025
- Developers' draft Environmental Statement states 'Significant adverse effects' on landscape, heritage etc.
- Major effects on Pumsaint and surrounding areas
- Roadway passes over the Roman Fort at Pumsaint A Scheduled Ancient Monument

Waun Maenllwyd Wind Energy Hub





- Developed by Belltown Energy
- Six wind turbines, five up to 200m tall together with associated infrastructure and access routes
- Public consultation deadline 29th October 2025, aim to submit formal submission end 2025
- Developers' draft Environmental Statement notes disturbance to peat bogs and watercourses and the excavation of 103,467 cubic metres of aggregate from borrow pits on site
- Major effects on the important mid-Wales red squirrel population and would be a dominant feature of the Cambrian Hills from the Ceredigion Coast
- Roadway passes over the Roman Fort at Pumsaint A
 Scheduled Ancient Monument

Glyn Cothi / Brechfa East





- Up to 27 turbines up to 250 m tall
- Private company wholly owned by the Welsh Government
- Within NRW owned land including Brechfa Forest
- Submission of planning application target early 2027 with 2030 construction works

Nant Ceiment





- Developer Bute Energy
- 13 turbines up to 220m
- At early stages
- Aiming to submit development application in Q4 2026
- Local campaigners have joined forces with
 DimTyrbinau as it affects much of the same area
 as Brechfa East /Glyn Cothi

Pylon Chains





- GreenGen / Bute Energy 2 pylon chains
- Possible 400KV National Grid pylon chain currently unknown route through Carmarthenshire to Llandyfaelog
- Various campaign groups along route and into Powys and Cardiganshire

- <u>Heolddu Solar Farm</u> Tywi valley near Ferryside:


- Both located in sensitive locations

 2040 Solar zones








What will they look like for us?



- New turbines are 230 m or 750 ft tall to the tip of their blades. Up to 250 m being considered for Brechfa East (Glyn Cothi)
- Red lights on top to warn aircraft day and night
- As close as 500 m from your home if you live in the pre-assessed area
- Hillsides will be carpeted in solar panels and battery storage plants



What will be the cumulative impact?







Where will they get the materials?





- The 200m turbines being constructed in Scotland The foundation required 750 cubic metres (1,875 tonnes) of concrete
- Planned west Wales turbines are larger than this and will need bigger foundations
- Brechfa forest faces significant quarrying operations to "win" the aggregate for the Trydan Gwyrdd Cymru turbines
- Likely see this pattern repeated throughout the turbine and pylon sites in west Wales multiplying the environmental damage

Why should we be against energy parks?



- Loss of amenity: noise, light pollution and planning blight
- No grid upgrade or free electricity for residents
- Loss of jobs in the farming and tourism sectors
- Trees felled, hedgerows bulldozed, birds killed by turbines
- □ Landscape scarred by new roads and access routes
- Fire risk from power lines in woodland and battery storage
- Water supplies disrupted, communities flooded for hydro dams

- ✓ Fluffy grants to charities which may not materialise if companies go bust
- Farms bought by international companies swapping people for panels
- ✓ Very few long-term jobs as construction is undertaken by international teams

- Our cultural heritage and Welsh Language







- Each new Senedd seat such as Sir Gâr will have six members
- ► Pure proportional election under the D'hondt system and only parties with more than 12.5% of the vote will get a seat
- ➤ Sir Gâr in play with Plaid, Reform, Conservatives, Labour and others fighting for the 6 seats
- Demand answers from our MSs and Senedd Candidates as to what they will do to stop the destruction of our countryside

Change Welsh Government Policy



- Ask Senedd candidates to commit to a moratorium on development in Sir Gâr
- Senedd manifestos must reflect the need to prioritise our countryside and protect local people and jobs
- ► Get a commitment that political parties will redraft Future Wales 2040 to remove exploitation of our landscapes and to protect the Welsh countryside
- Renewables should be about communities not making millionaire executives richer
- ► Time to recognise the importance of Carmarthenshire's Countryside – Tywi Valley National Landscape (AONB)

Change of policy is needed before voting in May 2026







- West Wales hasn't seen change like this since the industrial revolution
- ► Energy Park proposals will not be defeated on technical or legal arguments alone
- ► In 2026 we will need to force a change in Welsh Government policy at the ballot box
- ► We must act now to preserve the Carmarthenshire we know before it is gone for good
